GENERAL DESCRIPTION OF TASK(S) AND OBJECTIVES TO BE ACHIEVED

Expected Activities:

Background

The African Agricultural Transformation Initiative (AATI) is an initiative co-founded by the International Fund for Agricultural Development (IFAD), the Bill & Melinda Gates Foundation (BMGF), the Alliance for a Green Revolution in Africa (AGRA), McKinsey & Company and is hosted by IFAD.

Over the next years, the AATI will seek to establish new (and strengthen existing) national agencies designed to support delivery of agricultural transformation policies and programmes, with the support of a central AATI unit. In addition to the Central Unit, the AATI include steering committee and an advisory board that will provide support and guidance. The initiative is expected to achieve three primary outcomes: (i) More inclusive, efficient, effective and impactful support provided to rural producers in flagship priority areas; (ii) Improvement of institutional capacity and capability in governments, and (iii) increased awareness and knowledge dissemination on success models, tools and approaches to agriculture.

In support of this initiative, the Consultant will join the Central Unit, under the overall leadership of the Executive Director, s/he will actively contribute to achieving, but not be limited to the following objectives and deliverables:

Objective

The M&E consultant will be assigned the task of establishing and enhancing the monitoring and evaluation (M&E) system of the AATI, aimed at bolstering accountability and enabling evidence-based decision-making. Responsibilities encompass examining current M&E documents and result frameworks and illustrating the Theory of Change visually. Additionally, the consultant will develop the M&E framework for the AATI, ensuring the establishment of clear indicators and methodologies where necessary. Furthermore, the Consultant will support to countries like Nigeria, Tanzania, and Sierra Leone in crafting customized M&E frameworks for their Agriculture Transformation Offices (ATO), aligning strategies with anticipated outcomes and reporting requirements. As part of ongoing efforts, the consultant will conduct reviews of achievements of the first and second quarters of 2024, ensuring precise reporting on progress and impact.

Deliverables

1. Conduct a thorough review of the existing M&E framework, identifying strengths, weaknesses, and areas for improvement. Recommend and implement enhancements to ensure alignment with AATI's

goals and objectives. Develop a robust framework for tracking progress towards desired outcomes, incorporating clear indicators and methodologies.

- 2. Provide direct support to Tanzania, Sierra Leone, and Nigeria in the development of tailored M&E frameworks for their Agriculture Transformation Offices (ATOs). Collaborate closely with national stakeholders to ensure alignment with priorities and reporting requirements.
- 3. Organize and lead virtual training sessions and workshops for ATO staff on M&E principles, methodologies, listed in the M&E framework. Equip participants with the knowledge to effectively implement and manage M&E systems, fostering a culture of data-driven decision-making.
- 4. Compile and analyse data to report on the achievements of the AATI during the first and second quarters of 2024. Assess progress against predetermined targets, identifying achievements and areas for improvement. Document achievements, challenges, and lessons learned during the evaluation period, providing insights for future planning and decision-making.
